Dear authors of the articles in the journal "Proceedings of BSTU"

We draw your attention to the fact that abstracts in English in the Russian-language edition are for foreign scientists and specialists the main and, as a rule, the only source of information about the content of the article and the research results presented in it. Foreign experts evaluate the publication with the help of an abstract, determine their interest in the work. An abstract in English for a Russian-language article may be larger than an abstract in Russian (150-200 words), since the Russian-language abstract is followed by a full text in the same language. The abstract should reflect the purpose of the research, the main content and novelty of the article in comparison with related topics and purpose, as well as the results obtained.

Pictures in articles should be clear, high-quality, readable. Figures are labeled in Times New Roman, 10 pt. The elements of the figures are numbered with Arabic numerals, highlighted in italics and explained in the figure captions. One image is not numbered.

Tables should not contain empty columns. The only table is not numbered.

Formulas are numbered only those to which the author refers in the text.

Only generally accepted abbreviations (abbreviations) should be used in the text. Abbreviations are not allowed in the title of the article. At the first mention, the full term should be given, and the abbreviation is given in brackets.

The article with a representative list of references demonstrates the professional outlook and the qualitative level of research of its authors. A correct description of the sources used in the bibliography is a guarantee that the cited publication will be taken into account when evaluating the scientific activities of its authors.

Experts from SCOPUS and other international databases negatively perceive the inclusion of the following sources in the References:

- 1) laws, regulations, GOSTs, instructions, as well as anonymous sources;
- 2) abstracts of dissertations, dissertations, newspapers, reports, teaching aids and text-books, local, hard-to-reach sources;
 - 3) electronic materials and resources of the Internet.

It is preferable to cite the indicated sources directly in the text or cite them in the form of footnotes at the bottom of the page.

We draw your attention to the fact that after the text of the article (before the information about the authors) it is necessary to mention examples of citation of your articles. Examples:
